170/14: COMMUNITY SPACE STEERING GROUP

- a. It was reported by Cllr. Meirion Jones with regards to the questionnaires, that the steering group are still collating the information & awaiting the return of more questionnaires.
- b. The clerk read out & presented a letter to the steering group, on behalf of the council stating the council's support in the steering group's endeavours in finding a community space.
- c. A copy of the Late Rev. David Jones will was presented & part read out re: Llanfynydd Charity School. It states that the Charity school at Llanfynydd "shall not be made use of for any other purpose than a Charity School." It was noted that the church is now looking into it. Claire Papworth requested a copy of the will, to be sent before Thursday 9th when the steering groups committee meeting is to take place.

171/14: HALL PLOT/COMMUNITY GARDEN

- a. Cllr. Mairwen Rees did cut the grass in September.
- b. Cllr. Brian Thomas has agreed to trim, in the near future.
- c. The School Headmaster contacted the clerk & pointed out that on clearing out the school they came across some gardening tools belonging to the council. He also stated that there were items in the basement such as outdoor tiles & gardening plastic etc. that the council may have. The clerk is to enquire as to whether the school is willing to store the said items for the council. It was mentioned that the Hall Plot may need a shed.
- d. Insurance – A letter was read out from Zurich Insurance stating that the council's policy will only cover events organised by the council. "Any groups, organisations or events which want to use the facilities will not be covered under your insurance and proof of liability cover should be requested from these groups who use your facilities. The reason we cannot cover them is purely that the third party are not the responsibility of the council and therefore claims and hazards cannot be prevented by the council." It was suggested that the council may look into future organised individual events.

172/14: ROAD MAINTENANCE

- a. 158a&k/14: Overhanging trees between Y Mans and Sgwar Pantycelyn, Capel Isaac & Pantycelyn Sq to Y Rheol and onto Crachdy Isaf farm - It was noted that Mr.Cundiff has cut his land but the unregistered land has not been cut. County Cllr. Charles is to follow up.
- b. 158b/14 Street Lighting between Hall Plot & Ael Y Bryn – It was noted that the work has not been done. County Cllr. Charles is to follow up.
- c. 88/158e14d: Clearing ditches – Gwaelod y Maes. It was noted that this work has been done. No further action required.
- d. 158d/14: Overhanging trees & Subsidence at Pantmawr, Llanfynydd, and along the Llanfynydd to Abergorlech road (Pantgwyrd, past Panthowell on the left) – Cllr. Charles has sent an email to Ian Thomas. It was noted that the land is owned by the new owners of Panthowell. **To be reviewed at next meeting.**
